



## **AAA Connect Guidelines**

This Guideline derives from the AAA Connect Principles, and governs our relationship with users and others who interact with AAA Connect. By using or accessing AAA Connect, you agree to this Guideline.

### **Privacy**

Your privacy is very important to us. This guideline has important disclosures about how you can use AAA Connect to share with others and how we collect and can use your content and information. We encourage you to read the Guidelines, and to use it to help make informed decisions.

### **Sharing Your Content and Information**

You own all of the content and information you post on AAA Connect and you can control how it is shared. We always appreciate your feedback or other suggestions about AAA Connect, but you understand that we may use them without any obligation to compensate you for them (just as you have no obligation to offer them).

### **Safety**

We do our best to keep AAA Connect safe, but we cannot guarantee it. We need your help to do that, which includes the following commitments:

- ✓ You will not collect users' content or information, or otherwise access AAA Connect, using automated means (such as harvesting bots, robots, spiders, or scrapers) without our permission.
- ✓ You will not upload viruses or other malicious code.
- ✓ You will not solicit login information or access an account belonging to someone else.





- ✓ You will not bully, intimidate, or harass any user.
- ✓ You will not post content that is hateful, threatening, pornographic, or that contains nudity or graphic or gratuitous violence.
- ✓ You will not develop or operate a third party application containing, or advertise or otherwise market alcohol-related or other mature content without appropriate age-based restrictions.
- ✓ You will not offer any contest, giveaway, or sweepstakes ("promotion") on AAA Connect without our prior written consent. If we consent, you take full responsibility for the promotion, and will follow our Promotions Guidelines and all applicable laws.
- ✓ You will not use AAA Connect to do anything unlawful, misleading, malicious, or discriminatory.
- ✓ You will not do anything that could disable, overburden, or impair the proper working of AAA Connect, such as a denial of service attack.
- ✓ You will not facilitate or encourage any violations of this Guideline.

## **Registration and Account Security**

AAA Connect users provide their real names and information, and we need your help to keep it that way. Here are some commitments you make to us relating to registering and maintaining the security of your account:

- ✓ You will not provide any false personal information on AAA Connect, or create an account for anyone other than yourself without permission.
- ✓ You will not use AAA Connect if you are a convicted sex offender.
- ✓ You will keep your contact information accurate and up-to-date.
- ✓ You will not share your password, let anyone else access your account, or do anything else that might jeopardize the security of your account.
- ✓ You will not transfer your account to anyone without first getting our written permission.
- ✓ If you select a username for your account we reserve the right to remove or reclaim it if we believe appropriate (such as when a trademark owner complains about a username that does not closely relate to a user's actual name).



## Protecting Other People's Rights

We respect other people's rights, and expect you to do the same.

- ✓ You will not post content or take any action on AAA Connect that infringes or violates someone else's rights or otherwise violates the law.
- ✓ We can remove any content or information you post on AAA Connect if we believe that it violates this Guideline.
- ✓ If you collect information from users, you will: obtain their consent, make it clear you (and not AAA Connect) are the one collecting their information, and post a privacy policy explaining what information you collect and how you will use it.
- ✓ You will not post anyone's identification documents or sensitive financial information on AAA Connect.

## Other:

- ✓ This Guideline makes up the entire agreement between the parties regarding AAA Connect, and supersedes any prior agreements.
- ✓ If any portion of this Guideline is found to be unenforceable, the remaining portion will remain in full force and effect.
- ✓ If we fail to enforce any of this Guideline, it will not be considered a waiver.
- ✓ Any amendment to or waiver of this Guideline must be made in writing and signed by us.
- ✓ You will not transfer any of your rights or obligations under this Guideline to anyone else without our consent.
- ✓ All of our rights and obligations under this Guideline are freely assignable by us in connection with a merger, acquisition, or sale of assets, or by operation of law or otherwise.
- ✓ Nothing in this Guideline shall prevent us from complying with the law.
- ✓ This Guideline does not confer any third party beneficiary rights.
